**Health Effects**

**Acute - Swallowed** May cause mild gastric irritation if swallowed.  
**Acute - Eye** May cause watering of eyes.

**First Aid**

**PRECAUTIONS FOR USE**

**Exposure Limits** No exposure standard has been established for this product.  
**Other Exposure Info.** Exposure Standard means the average concentration of a particular substance in the worker's breathing zone, exposure to which, according to current knowledge, should not cause adverse health effects nor cause undue discomfort to nearly all workers.

It can be of three forms; time-weighted average (TWA), peak limitation, or short term exposure limit (STEL). Occupational exposure limits: When an exposure standard has not been established by the National Occupational Health & Safety Commission for a material, a blanket recommendation of 5 mg/m<sup>3</sup> for respirable vapours, mists and dusts should be used.

**Eng. Controls**

Maintain concentration below recommended exposure limit. Special ventilation is not normally required due to the low volatility of the product at normal temperatures.

However, in the operation of certain equipment or at elevated temperatures, mists or vapour may be generated and exhaust ventilation should be provided to maintain airborne concentration levels below the exposure standard or where no exposure standard is allocated, as low as is reasonably practicable.

**Personal Protection**

**Respirator Type**

(AS 1716)

Respirator not normally required.

Airborne concentrations should be kept to lowest levels possible. If vapour, mist or dust is generated and the occupational exposure limit of the product is exceeded, use appropriate AS/NZS 1715/1716 approved half-face filter respirator suitable for organic vapours or air supplied respirator after determining the airborne concentration of the contaminant. Air supplied respirators should always be worn when airborne concentration of the contaminant or oxygen content of the air is unknown.

Safety glasses, goggles or faceshield as appropriate.

PVC, neoprene or nitrile rubber gloves.
